Credit Line: On The Go Solutions, Inc may assign Applicants a credit line, which, in its sole discretion, On The Go Solutions, Inc may increase, decrease, or terminate at any time without prior notice to Applicant, except as otherwise provided by law.

Payment: Payment of the invoiced amount of goods purchased from On The Go Solutions, Inc shall be made in the amount and pursuant to the terms set forth on each invoice. If Applicant defaults in making payment when due, the total outstanding balance of all invoices together with interest and collection costs as provided for herein, shall become immediately due and payable.

Interest: Applicant agrees to pay interest in the amount of either (i) 1.5% per month, (ii) the highest rate permitted by law, whichever is less, on any payment past due.
